In view of recognition of National Council for Teacher Education and recommendation of different committee i.e Affiliation and New Teaching Programme Committee, Board of Affiliation and in anticipation of the Court's approval, your institute is granted the provisional affiliation (for one year) for Bachelor of Education course with intake as per N.C.T.E approval letter w.e.f the academic session 2016-17, subject to the approval by the State Government. Your institute is granted provisional affiliation to Aryabhatta Knowledge University, Patna on the following terms & conditions:-

1. The extension of provisional affiliation is presently for one year only for the academic session 2016-17.
2. The extension of provisional affiliation is based upon the approval accorded to your institute by the NCTE vide F.ERC/NCTE/ERCAPP955/B.Ed.(Revised Order)/2015/32470 dated 30-05-2015.
3. The extension of provisional affiliation is granted for Bachelor of Education course programme of two years duration with an annual intake of 100 seats (two unit) for academic session 2016-17.
4. This extension of provisional affiliation is subjected to your attending to all the deficiencies pointed out by the Inspection team in its report dated 31-07-2016 (copy attached) within a period of six month from the date of issue of this letter.
5. Further you have to inform the university through affidavit that you have removed all the deficiencies as intimated to you vide "4" above, failing which the provisional affiliation, accorded through this letter, shall be deemed to have been automatically withdrawn.
